- a) Kings Head Static Caravans the Planning Enforcement Officer Peter Scott didn't think that the amount the caravan sitings deviated from the plan was sufficient to enable action. Although the pumping noise keeps being mentioned by residents RD to give clerk words to email and LH a map Action 37/24
- **b)** Bowman's work has stopped at the moment on a voluntary basis. The contamination on the planning condition needs to be addressed. Then they will need to put an application in to take that condition off re the contamination.
- c) Butlins extra caravans land west of Butlins Skegness clerk to send objection email in as will increase traffic and put extra pressure on services resolved unanimously. **Action 38/24**
