6) CLERK'S REPORT ON MATTERS OUTSTANDING.

a) Land at Chapel Road, Ingoldmells: It has been previously reported that a large amount of waste has been dumped/fly tipped in a field off the A52.

This is the third time this has happened. A planning Officer who was travelling through the village spotted this and had already raised an inquiry with the enforcement officer. An officer has been allocated the case and will be following this up with a view to prosecution.

b) No meetings to be held during the Covid-19 pandemic/crisis: The recommended course of action was to hold 'Video Link' meetings using Zoom technology. However as none of the Councillors were comfortable with the technology involved, and not all had access to a computer, the clerk drew up a procedure whereby the Council could continue to function, by using the postal and phone systems. The Parish Council generally has very little business to discuss and it was agreed that we could maintain working by this method.
