6) CLERK'S REPORT ON MATTERS OUTSTANDING.

a) Cesspit Legislation: The clerk has checked on the Gov.UK website and printed the information. Any septic tank that drains into surface such as a water course must be replaced or upgraded to prevent this and this is the responsibility of the home owner. Tanks will need to checked and any

necessary improvements made. The Environment Agency published the 'General Binding Rules' in 2015 and this legislation now comes into force on 1st January 2020. Large scale drainage of water into a water course will require a special permit.

- b) Trees in Chapel Lane: The damaged trees in Chapel Lane were reported to Highways and have now been cut back and made safe.
- c) Sign for Village Green: a new sign was purchased for the gate on the green asking motorists not to park in front of the gate as the edges of the culvert were being damaged and becoming liable to fall away. The sign was passed to Cllr T. Smith who would make sure it was attached to the gate.
- d) Kings Head advert: a letter from ELDC Planning Dept confirms that the file has been passed to the legal dept for consideration of a prosecution because the banner contravenes advertising rules and despite numerous warnings to remove it, no action has been taken to do so.
