a) Community Speed Watch: Various members of the Lincolnshire Road Safety Partnership have been in contact with the clerk about setting up a Community Speedwatch Group, have offered a traffic survey and advice on Speed Indicator Signs for the village. The Clerk has suggested that any traffic survey is carried out after Easter when the caravan sites have re-opened as the extra traffic can then be observed. Advice at present is that possibly 4x 'SID' signs would probably be sufficient, and the clerk explained that hopefully these could be run by Solar Panels as large parts of the village do not have street lamps which is the usual means of display.
